

OFFICIAL SWEEPSTAKES RULES AND REGULATIONS

NO PURCHASE NECESSARY. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR REDEEM PRIZE.

SUBMISSION AND SWEEPSTAKES PERIOD: Sweepstakes begins at 12:00 PM CST (Central Standard Time) Tuesday, Sep 8, 2020 and the sweepstakes entry period ends at 12:00 PM CST (Central Standard Time) on Wednesday, Sep 30, 2020 (The "Drawing Deadline"). The period commencing at the Start Time and ending at the Drawing Deadline is referred to herein as the "Sweepstakes Period."

ENTRY: No purchase is necessary to participate in the Sweepstakes. A purchase will not increase your chances of winning. Odds of winning will depend on the total number of entries received.
